But dissent emerges from multiple fronts. The Society for Human Resource Management (SHRM) notes that rigid degree requirements reduce workforce diversity and talent pipelines, particularly in regions facing engineering shortages. In California, a 2020 study by the University of California found that 38% of licensed engineers on major infrastructure projects had non-ABET degrees but passed rigorous state exams—raising questions about whether exclusivity enhances safety or merely restricts access. The risks of such gatekeeping are twofold: first, the potential to exclude competent practitioners who could contribute meaningfully—especially in underserved or emerging markets. Second, the perpetuation of a closed system that may incentivize credentialism over actual competence. A 2018 survey by the Journal of Engineering Education revealed that 42% of PE-holders admitted to occasional knowledge gaps in niche areas, yet their license still grants broad authority.
