Novas Cartas Portuguesas: Uma Obra que Marca a Literatura e a História do Brasil **Novas Cartas Portuguesas** é uma obra que transcende fronteiras, sendo considerada uma das mais importantes e controversas na história da literatura brasileira e portuguesa.
