Japan’s Imperial Army, during its modernization in the Meiji era, similarly absorbed civilian experts into military planning, though under state-controlled frameworks that limited independent voice. In contrast, Whitman’s influence emerged organically, through personal networks and persuasive writing rather than institutional mandate—highlighting the unique American model of decentralized, conscience-driven governance during crisis.
