NexusCom's stock plummeted by 37% in the weeks following the leak, triggering a cascade of audits, contract terminations, and a class-action lawsuit alleging "systemic negligence in safeguarding personal data." A 2024 report by McKinsey estimated that U.S. federal agencies would spend \$12–15 billion over five years to overhaul data governance frameworks, with a particular emphasis on "privacy by design" and mandatory third-party penetration testing.
