His eventual recognition, including an Oscar in 1961, came too late to restore his professional standing. The blacklist's reach extended beyond politics. Labor activists, gay performers, and union organizers were similarly targeted, reflecting broader societal repression. The FBI's COINTELPRO program later intensified these tactics, infiltrating studios and manipulating industry narratives. The 1952 screen test, mandated by the HUAC, forced employees to affirm they were not members of the Communist Party—a ritual of compliance that normalized surveillance. This purging reshaped American cinema. It eliminated radical voices that might have challenged capitalist norms, decimated creative diversity, and entrenched a culture of fear. As historian Peter Kuznick notes, the blacklist “transformed Hollywood from a space of artistic experimentation into a theater of ideological

conformity.” The consequences were long-lasting: stories that might have confronted inequality, war, or corruption were muted or erased, leaving a legacy of sanitized narratives that persist in mainstream cinema today.

The Global Reach and Cultural Imperialism
