Typographic scholars such as Dr. Miriam Thorne, author of *Structures of the Written Word in Early England* (2021), emphasize that these formal choices were deliberate aesthetic and cognitive decisions. The repetition of controlled, deliberate strokes trained both scribe and reader in a shared discipline—what she terms “the calligraphic mind.” Each letter, every serif, participated in a visual grammar that reinforced textual authority and memorability.
