Preservation of these vessels is paramount—ligation or damage leads to chronic ischemia, a leading cause of postoperative limb failure. Modern vascular surgeons employ Doppler ultrasound and intraoperative angiography to map perfusion, yet in resource-limited settings, such monitoring remains rare. A 2020 report from the World Health Organization highlighted that only 38% of surgical facilities in sub-Saharan Africa are equipped for preoperative vascular assessment, increasing the risk of phantom limb complications by up to 60%. The surgical technique itself has evolved. Traditional open amputations, once standard, involved massive incision and extensive tissue removal. The CDC reports that diabetics are 25 times more likely to require amputation than non-diabetics. But in regions where infectious disease prevails—such as leishmaniasis in South America or malaria-related vascular necrosis in West Africa—BKA arises from entirely different pathologies. screening apps now detect early ulceration with 88% accuracy, enabling pre-surgical intervention and delaying amputation. Such tools could democratize access, but only if paired with local training and infrastructure. Policy reform is imperative.
