Countries adopting the model—particularly those with fragile agricultural sectors—face a dilemma: embrace foreign investment and technological transfer for immediate productivity gains, or resist and risk food dependency and rural decline. In Indonesia, for example, government officials have positioned the project as a cornerstone of the “Food Resilience 2030” initiative, promising reduced import bills and job creation. Yet critics argue it cedes long-term control over a strategic commodity to multinational entities, potentially undermining sovereignty in times of crisis. The proposal’s governance structure—featuring joint oversight committees with foreign corporate representatives—has raised legal and ethical concerns about democratic accountability.
