Crucially, no single manuscript bears the full title or opus number with definitive authenticity. Instead, scholars refer to a composite of surviving sketches, rehearsal leaves, and later transcriptions—some derived from student copies, others from direct copies made by contemporaries such as Carl Czerny or Ferdinand Ries. The earliest extant printed version, published in 1823 by Breitkopf & Härtel in Leipzig, presents a revised and abridged form, likely shaped by editorial intervention and the commercial imperatives of a publishing house eager to capitalize on Beethoven's rising posthumous fame. This edition omits entire movements and condenses others, raising enduring questions about authenticity, fidelity, and the role of the publisher as author.

The Geopolitical and Economic Context: Vienna, Berlin, and the Birth of a Canon Beethoven's creative period, spanning roughly 1803 to 1827, coincided with profound geopolitical transformation. The Napoleonic Wars destabilized Central Europe, fracturing the Holy Roman Empire and reshaping the political landscape in which composers operated. Vienna, once the undisputed cultural capital, found itself a city in flux—its aristocratic patronage system eroding under revolutionary pressures and shifting power structures. Beethoven, increasingly isolated and deaf, navigated this turbulence not merely as an artist but as a figure of revolutionary ideals and commercial pragmatism. The circulation of his works—including what became Opus 7—was mediated by a nascent music industry. Yet, unlike works by contemporaries such as Haydn or Mozart, Beethoven's output was not systematically compiled or monetized during his lifetime. Opus 7, unpublished at the time, exemplifies this liminality—a composition with artistic potential but limited commercial incentive. The economic model

of musical dissemination was still embryonic. Printed scores were expensive, accessible only to professionals or wealthy amateurs. Manuscripts circulated through private networks: students, publishers, and performers who copied, performed, and preserved works informally. Musicologist Christoph Wolff, in his analysis of Beethoven’s compositional habitus, emphasizes that the sonata’s fragments reflect a composer in deep internal dialogue—one grappling with form, expression, and the limits of language. Wolff argues that the work’s incompleteness is not a flaw but a window into Beethoven’s creative process: a “work-in-progress” that resists closure, inviting performers to engage not as reproducer but as co-creator. Performance practice further complicates this. Pianists such as Mitsuko Uchida and Elena Petrova have approached Opus 7 with caution, citing the lack of a definitive score and the risk of over-interpretation. Yet others, like the avant-garde pianist Marc-André Hamelin, have embraced its ambiguity, using it as a basis for improvisatory exploration—blurring the line between scholarly reconstruction and contemporary expression. The debate extends to editorial ethics. The 2018 critical edition by the Beethoven-Gesellschaft Berlin, which synthesizes multiple fragments and comparative sources, attempts to balance fidelity with scholarly rigor. Yet, as music theorist Susan McClary notes, every editorial choice—what to include, omit, or infer—reflects a political act, embedding contemporary values into historical reconstruction. Controversies and Risks: The Fragility of Heritage The handling of Beethoven 7 is not without risk. Experts swiftly exposed it as a 20th-century fabrication, highlighting the vulnerability of unpublished works in the digital age. Such incidents underscore the need for rigorous provenance checks and international collaboration among archives, museums, and academic institutions. Legal and ethical dimensions also loom. Copyright law, designed for published works, offers limited protection for

unpublished fragments. Who owns the rights to a Beethoven “lost” sonata? The Beethoven-Haus Bonn asserts stewardship, but global repositories like IMSLP operate under open-access principles, creating jurisdictional and moral tensions. These conflicts reflect broader debates about cultural heritage: should unpublished works be preserved in the public domain, or safeguarded under institutional custodianship?
