Here, the personal becomes political: the dream of equality is not abstract but embodied in the daily struggle for dignity. His association with the John Reed Club, named after the revolutionary journalist, and his contributions to left-wing publications like **The Crisis** and **New Masses**, situated his work within broader struggles for economic justice. Poems such as "The Negro Speaks of Rivers" (1921, revised 1925) exemplify this synthesis. With its mythopoetic invocation—"I've known rivers: I've known rivers ancient, dusky rivers"—Hughes situates Black identity within the deep, timeless flow of history, linking individual consciousness to the Nile, Euphrates, and Congo. The poem transcends ethnographic record; it asserts a transnational, ancestral continuity that resists erasure. Economically, this was a radical act in a moment when Black labor was exploited and devalued. His 1951 testimony before the House Un-American Activities Committee—where he defended his artistic freedom with quiet defiance—reveals the precarious balance between political expression and personal safety. This period saw a shift in his tone: while earlier work celebrated hope and resilience, later poems grapple with disillusionment, aging, and the slow pace of change. “Harlem” (1951), famously titled “A Dream Deferred,” distills the psychological toll of systemic neglect: “Does it dry up / like a raisin in the sun? / Or fester like a sore— / And then run?” The poem’s brevity belies its depth—it is not merely about unfulfilled aspirations but the toxic incubation of unmet potential, a metaphor with enduring relevance in contexts of structural inequality. Hughes’s engagement with the civil rights movement was both supportive and nuanced. While he admired Martin Luther King Jr.’s leadership, he critiqued the movement’s occasional embrace of respectability politics, advocating instead for a poetry and politics rooted in Black vernacular, joy, and communal experience. His 1967 collection *The Panther and the Lash** reflects this tension, addressing police brutality and Black self-defense with unflinching clarity. Poems like “Let America—” (revised in later editions) revisit earlier themes with renewed urgency, framing racial justice not as a request but as a demand born of historical debt. The geopolitical dimensions of Hughes’s work extend beyond U.S. borders. His travels to Africa, the Caribbean, and Europe exposed him to global Black diasporic movements. His poetry absorbed influences from Caribbean writers like Claude McKay and Caribbean jazz, blending them with his American roots. In “Theme for English B” (1951), delivered as a lecture to an integrated class, Hughes confronts racial identity through the lens of education and personal narrative: “I am the son of two races”—a statement both intimate and geopolitical, acknowledging the fractured legacies of colonialism, slavery, and migration. The poem’s classroom setting is a microcosm of America’s fractured social order, yet Hughes insists on commonality: “I’ve

been America— I’ve been the Negro, I’ve been the dream, I’ve been the night, I’ve been the day.” Here, identity is not fixed but performative, shaped by context and encounter—an insight with profound implications for global understandings of hybridity and belonging. Economically, Hughes’s work anticipated later cultural economy theories: he understood art not as luxury but as vital infrastructure. His poetry, performance, and prose—from **Not Without Laughter** (1930) to **Montage of a Dream Deferred** (1951)—created ecosystems of cultural production that empowered Black communities. He rejected patronage models that demanded assimilation, instead championing authenticity and accessibility.
