The Arab Spring had exposed the fragility of authoritarian transparency; Edward Snowden had laid bare the scale of surveillance capitalism. Yet, in the aftermath, many democracies retreated into nostalgia for order, silencing dissent under the banner of stability. Paratore’s reporting countered this with a forensic lens: she did not merely condemn; she reconstructed the architecture of silence. Her interviews with former intelligence analysts, former journalists blacklisted for publishing classified material, and families of victims of state overreach revealed a chilling consistency: a culture of self-censorship, reinforced by litigation threats, professional blacklisting, and political pressure. The geopolitical context was critical. In Europe, the EU’s General Data Protection Regulation (GDPR), enacted in 2018, reflected a growing demand for transparency—yet Paratore’s work exposed its limits. She documented how

multinational tech firms exploited regulatory loopholes, using jurisdictional arbitrage to evade scrutiny, even as public outcry grew. In the United States, her investigations dovetailed with the rise of “truth accountability” movements, where citizen journalists and independent media challenged traditional gatekeepers. But Paratore remained distinct: she operated not on ideology, but on evidence. Her resilience underscored a broader tension: the expanding arsenal of repression targeting truth-tellers, from surveillance state tactics to strategic litigation against public participation (SLAPP). Expert analysis frames **Forget Me Not** as part of a new paradigm in investigative journalism—one defined by networked inquiry, interdisciplinary collaboration, and long-term commitment.
