The U.S. Securities and Exchange Commission (SEC) now mandates that major financial institutions conduct annual "stress familiarization" drills modeled on Tapas principles—assessing readiness for black swan events that defy conventional models. This shift reflects a broader recognition: in an era of hyperconnectivity, risk is no longer contained within organizational boundaries but flows through a global nervous system.

Expert Perspectives: Cognitive Load, Groupthink, and the Illusion of Control Behind Tapas Test lies a sophisticated understanding of cognitive psychology and organizational behavior.
