She studied computer science at the Indian Institute of Technology Bombay, but her real education unfolded in the informal economies of data: the underground networks of metadata flows, the unspoken rules of data ownership in rural cooperatives, and the quiet resistance of communities demanding control over their digital footprints. Her early career at the National Informatics Centre (NIC) exposed her to the contradictions of state data systems—efficient in capture, but opaque in use, centralized in control, and alienated from local realities. It was during her tenure at the Centre for Internet and Society (CIS) in the mid-2010s that Kedar began conceptualizing dbms not as a tool, but as a paradigm. Conventional database management systems (DBMS), she argued, were designed for centralized authority—optimized for SQL queries, transactional integrity, and corporate scalability. This conceptual leap was not born in isolation. It emerged

from a broader global reckoning with data colonialism—the phenomenon by which powerful nations and corporations extract, process, and monetize data from less powerful regions without equitable return. Kedar’s work resonates with scholars like Shoshana Zuboff, whose critique of surveillance capitalism laid intellectual groundwork, but diverges sharply in its decentralized, community-centered design philosophy. Where Zuboff warned of corporate overreach, Kedar proposed a counter-ecology: data systems co-designed with users, governed by layered consent, and interoperable across borders but anchored in local sovereignty.

Origins in Crisis: The Geopolitical and Economic Catalysts

Kedar’s breakthrough came during the 2016–2017 wave of digital rights activism across South Asia and Africa. Governments were expanding digital ID programs—Aadhaar in India, e-Ghana, Kenya’s Huduma—often under pressure from international financial institutions demanding “e-efficient” public services. Yet these systems frequently marginalized rural populations, disabled persons, and informal workers, whose lives did not fit rigid biometric templates. Data was collected, stored, and analyzed in centralized clouds—often overseas—exacerbating fears of surveillance and exclusion. Kedar responded not with protest, but with architectural innovation. She co-founded the Open Data Commons Initiative (ODCI), a non-profit platform that developed dbms with modular, open-source kernels capable of running on edge devices: local servers in community centers,

rural health clinics, or cooperative warehouses. The results were striking: processing delays dropped by 40%, patient consent workflows became transparent, and community health workers gained real-time access to localized insights—without ceding sovereignty. Internationally, dbms inspired analogous

movements. In Brazil, the National Data Bureau adopted adaptive schema principles in its open government platform. In Senegal, decentralized data commons built on dbms architecture now manage agricultural supply chains, empowering cooperatives to track produce from farm to market with full auditability. The World Bank’s 2023 Digital Public Infrastructure Report cited dbms as a “model for inclusive data governance,” particularly for low-resource settings where centralized systems fail. The system evolves with its users, not against them.” The philosophical foundation of dbms draws from multiple traditions: the Indian concept of **sangathana**—collective coherence; Ubuntu ethics from Southern Africa, “I am because we are”; and the Scandinavian emphasis on data as a public trust. This pluralistic epistemology positions dbms not as a technology, but as a cultural artifact—one that redefines data not as property, but as a shared responsibility.

Controversies and Risks: Sovereignty vs. Fragmentation

No systemic shift occurs without friction. dbms, despite its noble aims, has sparked debate over implementation risks. Critics, including some cybersecurity experts, warn of increased attack surfaces: decentralized nodes may be harder to secure than centralized databases.
