Florida's role as a sanctuary for offshore finance and its lax regulatory regime has turned it into a node in transnational systems of exploitation. The state's financial institutions process billions in anonymous flows, some linked to human trafficking and sexual exploitation. The IRS and state auditors have repeatedly flagged suspicious activity in real estate transactions—particularly in Orange Park and Fort Lauderdale—where cash purchases, shell companies, and nominee ownership obscure beneficial ownership. These mechanisms enable abusers to hide, finance operations, and evade justice. A 2023 report by the Financial Accountability and Oversight Board found over \$1.3 billion in unreported real estate activity tied to domestic violence cases, suggesting a hidden economy of coercion. Geopolitically, Florida's vulnerability is amplified by its symbolic status. To adversaries, it represents American weakness—soft borders, porous sovereignty, and internal division. Russian and Chinese intelligence assessments, as disclosed in declassified U.S. intelligence summaries, identify Florida's demographic diversity and economic leverage as strategic vulnerabilities. The state's proximity to Latin America and the Caribbean,

combined with its media influence and financial centrality, makes it a battleground for soft power. Yet rather than addressing systemic flaws, political responses have often reinforced repression: expanded surveillance, restrictive immigration policies, and underfunded victim services.
