The global IP regime, long anchored in bilateral and multilateral treaties—most notably the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) under the WTO—was under unprecedented scrutiny. The Doha Declaration of 2001 had already acknowledged flexibilities for public health emergencies, yet enforcement gaps and enforcement asymmetries persisted. Now, in 2023, these tensions converged with new technological frontiers: artificial intelligence, biotech breakthroughs, decentralized digital assets, and the weaponization of IP in great power competition.

Geopolitical fault lines defined the 2023 IP environment. The 2023 compromise—a limited, voluntary licensing framework—was seen by critics as a stopgap, not a solution, revealing the structural imbalance in global IP governance. In biotech, CRISPR gene-editing patents became battlegrounds not just for scientific ownership but for ethical control over human germline modification. Biotech firms now deploy layered IP strategies—combining composition-of-matter patents, delivery mechanisms, and therapeutic applications—creating dense defensive walls that deter competitors. In artificial intelligence, the absence of clear global standards for AI-generated works created regulatory chaos. U.S. copyright law, for instance, denied protection to works solely created by AI, yet allowed rights for human-curated outputs—leaving a gray zone exploited by platforms training models on vast datasets. The EU’s proposed AI Act introduced risk-based IP obligations, requiring transparency in training data use,

while China's approach emphasized state-directed innovation, with AI models developed via state-subsidized IP consolidation. The result: a fragmented global regime where IP ownership in AI is as much a legal question as a technical one. Trademarks and digital branding evolved under the weight of the metaverse and Web3. NFTs and virtual goods introduced novel challenges: who owns a digital artwork displayed in a virtual gallery? Who enforces IP rights across decentralized platforms? The U.S. Trademark Office responded by clarifying that virtual trademarks could be registered and enforced, but enforcement remains elusive without centralized authority. This “patent shopping” distorted innovation incentives, privileging legal engineering over genuine invention.
