The Chinese model, emphasizing rapid extraction over sustainability, reinforces the informal networks by incentivizing speed over compliance. Meanwhile, Western powers, particularly the United States and members of the European Union, have responded to supply chain vulnerabilities by promoting “friend-shoring” and diversifying sources. Initiatives like the U.S. Minerals Security Partnership and the EU's Critical Raw Materials Act aim to reduce dependence on China by funding mining projects in Africa—including in the DRC—often through private-sector intermediaries that blur lines between formal and informal trade. Regional dynamics further complicate the

landscape. Neighboring countries such as Rwanda, Uganda, and South Africa serve as both sources and transit hubs for illicit minerals. Reports by the United Nations Group of Experts on the DRC have documented cross-border smuggling networks that route coltan, gold, and tin through informal trade corridors, often facilitated by corrupt border officials. These flows sustain armed groups in eastern DRC, who exploit mineral wealth to finance conflict, while regional states benefit from trade revenue and political leverage. The African Union and the Southern African Development Community (SADC) have attempted to establish regional monitoring mechanisms, but enforcement remains weak.
