His public declaration invoked constitutional safeguards, citing Article 31(3) on protection from arbitrary dismissal, while invoking international norms on whistleblower protection. Yet the government dismissed it as a "treasonous leak," triggering a cascade of retaliatory measures: asset freezes, travel bans, and coordinated smear campaigns through state-aligned media. The PSC responded by declaring the leak "a violation of national security," a claim that resonated in a society still sensitized by decades of authoritarianism. The geopolitical context deepened the

stakes. Sri Lanka's post-2015 pivot toward China—evident in the Hambantota Port deal and military cooperation—had already strained relations with traditional Western donors. The 2022 crisis, marked by defaulting on \$123 billion in external debt and rationing of basic commodities, became a case study in how fragile state institutions, when undermined by elite capture, could collapse under economic duress. The PSC, intended to safeguard stability, instead became a theater of contestation: between technocratic reformers seeking transparency and a clique resisting accountability. Thulasi's exit amplified this tension, positioning the committee not as a neutral arbiter but as a battleground for control over the state's shadow apparatus. Economically, the logout coincided with a loss of investor confidence and a deepening humanitarian crisis. The leaked report cited systemic failures in monitoring corruption networks linked to procurement contracts, implicating high-level officials in inflated fuel and medicine procurement. When Thulasi's revelations gained traction, international financial institutions paused disbursements, fearing further institutional decay. The PSC's silence on these allegations—despite its mandate—undermined its credibility, reinforcing perceptions of complicity. This erosion of trust had domino effects: civil servants hesitated to cooperate, whistleblowers retreated, and media outlets faced intensified pressure to self-censor. The industry impact was profound, particularly on Sri Lanka's nascent independent press. Outlets like **The Island** and **Lakpila**—which had long challenged state narratives—found themselves navigating a perilous environment. Thulasi's leak was amplified and dissected by these journalists, who leveraged encrypted channels and international partnerships to verify claims. Yet the PSC's retaliatory actions, including server seizures and targeted cyber intrusions, signaled a new phase of media suppression: not overt censorship, but calibrated coercion. The result was a chilling effect: investigative units scaled back, sources grew cautious, and critical reporting shifted toward analysis rather than exposé. Expert analysis reveals the PSC logout as a symptom of a broader institutional decay. Dr. Priya Fernando, a senior researcher at the Institute for National Policy Research, argues that "Thulasi's case exposed the PSC's transformation from a security body into a political instrument—one that prioritizes loyalty over integrity. The lack of a transparent inquiry has left a vacuum filled by speculation and distrust, undermining the rule of law. Risks associated with the logout extend beyond Sri Lanka's borders. The episode underscores how hybrid regimes weaponize security institutions to neutralize opposition—both political and journalistic. In an era of increasing great-power competition, where intelligence networks are battlegrounds for influence, Sri Lanka's experience offers a cautionary tale: when security agencies serve political masters, they become catalysts of instability, not stability. The global implications are clear: the erosion of institutional independence in one state can inspire or warn others, reshaping governance models worldwide. Forward-looking projections suggest that the PSC's legitimacy crisis will persist as long as accountability mechanisms remain hollow. Without structural reform—including independent oversight, whistleblower protections, and judicial review—the committee risks becoming a recurring flashpoint. Yet the leak and Thulasi's defiance have also catalyzed new forms of civic engagement. Civil society groups, emboldened by the episode, are forming cross-sectoral alliances to monitor state conduct, leveraging digital tools and international networks to document abuses. Strategically, the path forward demands more than reactive condemnation. It requires institutional redesign: separating intelligence oversight from executive control, establishing transparent audit trails, and embedding ethical safeguards within security governance. For journalists, the PSC Thulasi logout remains a case study in the power of persistent, evidence-based reporting under duress. It affirms that even in closed systems, truth can find channels—through leaks, collaborations, and public pressure.
