His early clientele included plantation-era families, sharecroppers, and emerging middle-class professionals, all bound by kinship, geography, and the unspoken expectation of dignity in farewell. The business grew incrementally, surviving the Great Depression through frugality and deep community trust. By 1940, the Scott operation had expanded into a full-service facility, complete with a chapel, hearse fleet, and even a burial plot section—anchored in the family’s belief that “souls must rest near those they knew.” The postwar era marked a turning point. As Charleston’s urban footprint expanded southward, Moncks Corner transformed from a rural crossroads into a suburban enclave. The Scott Funeral Home adapted, shifting from a local service to a regional provider.
