Their mandate was clear: to penetrate beyond the visible layers of digital systems and expose the embedded logics, power asymmetries, and emergent risks across five continents. Volume 1, released in late 2022, became the first public-facing dossier of the survey, though its raw materials were compiled over nearly four years through a hybrid methodology combining open-source intelligence (OSINT), secure interviews with insiders, encrypted document analysis, and cross-border data correlation.
