Dorner calls this “epistemic tunneling,” a cognitive trap where experts become so embedded in their models that they fail to recognize anomalies until collapse. His analysis of the 2011 Tōhoku earthquake and tsunami, for instance, reveals how Japan’s advanced early-warning systems and engineering standards were rendered ineffective not by a lack of data, but by a failure to account for cascading, multi-domain failure—where seismic activity triggered a nuclear crisis through a web of interdependent vulnerabilities. This epistemic failure is not confined to technical systems. Decision-makers, incentivized by short-term performance metrics and institutional prestige, suppress dissent and marginalize dissenting voices—what sociologists term “normalized communication.” In the case of Boeing, internal warnings about the MCAS system were sidelined by a culture that prioritized schedule adherence and shareholder value over safety. Dorner’s critique is not merely descriptive; it is diagnostic. He identifies a recurring pattern: failure arises not from individual incompetence, but from

systemic failures of listening, adaptation, and accountability. Geopolitically, Dorner's work intersects with the broader disintegration of consensus-based governance in an era of multipolarity and technological disruption. He argues that the logic of failure is increasingly globalized—errors in one domain cascade across borders through interconnected infrastructures, financial networks, and information ecosystems.
