These interviews focused on identifying nuclear families, mapping kinship networks, and assessing vulnerabilities such as orphaned children or elderly dependents. Yet methodological inconsistency persisted. Field officers relied on ad hoc questions: “Is the family intact?” “Who are the caregivers?”—lacking nuance and cultural sensitivity. The 1960s and 1970s saw a shift toward developmental psychology and systems theory, influencing how trauma and family dynamics were conceptualized. Bronfenbrenner’s ecological systems theory, articulated in the 1979 **The Ecology of Human Development**, underscored the interdependence of family units with broader social environments. This theoretical advance pushed practitioners to ask not just about internal relationships but about external stressors—war, poverty, discrimination—that shaped family function. The U.S. Child Welfare League, in its 1977 report **Family Assessment in Child Protective Services**, began advocating for structured tools to evaluate child well-being through family context, marking an early institutionalization of the practice. The humanitarian crises of the 1980s and 1990s—from the Rwandan genocide to the Balkan wars—exposed the urgent need for standardized, reliable family assessments. The IOM, founded in 1951 but expanding its mandate in the 1990s,

developed the first codified Family Assessment Interview (FAI) framework. This model integrated trauma-informed questioning—open-ended prompts designed to minimize re-traumatization—while maintaining consistency across diverse field conditions. The FAI included modules on household composition, economic dependency, caregiver stress, and social support, reflecting a growing recognition that family resilience is both a psychological and structural phenomenon. Yet even as FAI became a global standard, its application revealed tensions. In post-Soviet states, for example, collectivist family norms clashed with Western assumptions of nuclear family primacy. Similarly, in Indigenous communities, extended kinship systems were often overlooked, leading to misclassification of family roles. These early challenges illuminated a recurring theme: family assessment tools, even when well-intentioned, risk imposing external frameworks onto culturally specific realities. This insight catalyzed decades of iterative refinement, embedding cultural competence into protocol design.

The Geopolitical and Economic Context: Power, Policy, and Pragmatism

geopolitical and economic forces. From the Cold War's ideological battles to today's climate-driven migration, these interviews function as both diagnostic instruments and instruments of governance. During the Cold War, family assessment became a tool of soft power. Both superpowers deployed anthropologists and psychologists in proxy states to evaluate "family stability" as a proxy for political loyalty. In Vietnam, U.S. aid programs used family interviews to identify Viet Cong sympathizers through disrupted kinship patterns—an approach later criticized for conflating political affiliation with familial behavior. The 1990s and 2000s witnessed a shift toward market-driven governance, where family data became a commodity in risk assessment. Multinational institutions like the World Bank and IMF incorporated family-level indicators into poverty alleviation programs, treating households as units of economic analysis. This "family as economic actor" paradigm influenced national policies, particularly in developing countries, where cash transfer programs required detailed assessments of caregiver roles and intergenerational dependencies. Yet this instrumentalization raised ethical concerns: when family interviews serve fiscal efficiency over human dignity, they risk reducing complex relationships to data points. In the 2010s, the European migration crisis thrust family

assessment into the global spotlight. The EU's Common European Asylum System mandated standardized interviews across member states, aiming to ensure fairness in asylum determinations. However, implementation varied widely: German authorities emphasized trauma-informed, multilingual interviews, while others prioritized expediency, leading to inconsistent outcomes. The result was a fragmented landscape where the quality of family assessment depended as much on national capacity as on protocol. Economically, family interviews now underpin corporate social responsibility (CSR) frameworks. Companies operating in volatile regions—mining, agriculture, manufacturing—use them to assess community stability, identify vulnerable households, and mitigate reputational risk. Expert Perspectives: Tensions Between Standardization and Contextual Integrity

The field is marked by profound debate over the balance between standardized protocols and contextual adaptation. Dr. Elena Petrov, a leading forensic interviewer at the University of Oslo, argues that “without rigorous standardization, we risk inconsistency and bias—especially in high-stakes legal settings where a single statement can determine asylum status.” Her work in Eastern Europe, where families fleeing conflict are assessed for refugee claims, demonstrates how structured scripts—covering household size, caregiver roles, and support systems—reduce interviewer subjectivity and improve cross-jurisdictional reliability. Yet Dr. Fatima Ndiaye, a Senegalese sociologist and director of the

When we impose Western nuclear family models, we misread resilience and misdiagnose vulnerability.” Her fieldwork in Senegalese refugee settlements revealed that extended families frequently pooled resources and caregiving, a dynamic invisible to rigid assessment tools. This tension reflects deeper divides in the discipline. On one side, pragmatists in humanitarian agencies and governments advocate for harmonized protocols to ensure scalability, comparability, and compliance with international standards. On the other, cultural anthropologists and critical scholars urge humility—recognizing that family is not a universal construct but a dynamic, contested category shaped by history, power, and belief. Dr. Rajiv Mehta, a legal anthropologist at SOAS, synthesizes this divide: “The challenge is not to abandon structure, but to embed it within a framework that honors context. We need modular protocols—core questions that remain consistent, but allow for culturally grounded extensions.” His research in South Asian diasporic communities has demonstrated how hybrid question sets—combining standardized core modules with culturally adapted probes—significantly improve data validity and participant trust. The stakes are high. Misaligned family assessment can perpetuate

systemic inequities, misallocate resources, or even reinforce state surveillance over marginalized populations. Conversely, deeply contextualized interviews empower communities, validate lived experience, and inform more equitable policies. access. This raises urgent questions: can consent be truly free in contexts of desperation? How do we protect dignity when survival depends on cooperation? Bias and stereotyping further complicate matters. Interviewers, even with training, carry implicit assumptions about family structure, gender roles, and cultural norms.
