This model, piloted in Switzerland and adopted by the Metropolitan Opera and the Royal Opera House, signals a broader industry adaptation—where value is increasingly tied not to box office alone, but to archival depth, educational outreach, and cross-platform engagement. Within the industry, Volume 2 has become a litmus test for institutional credibility. Its inclusion in the 2025 UNESCO Intangible Cultural Heritage program underscores its role as a custodian of endangered vocal traditions. Yet, it has also ignited debate. Critics within the establishment argue that its experimental selections dilute the “purity” of the repertoire, while others accuse it of tokenism—selecting diversity without systemic change in hiring practices. Collaborations with sound engineers specializing in psychoacoustics ensured that the recordings evoke not just sound, but psychological space: the low rumble beneath a trembling high C, the silence after a sustained dissonance. These choices transform listening from passive consumption to immersive encounter, aligning with contemporary research in music cognition that highlights the brain’s response to micro-temporal variation in vocal timbre. The controversy surrounding the volume centers on authorship and appropriation. The inclusion of a 12-minute aria composed in collaboration with Sámi throat singers and Sami language scholars sparked debate. While lauded by indigenous cultural councils as decolonial praxis, some academic circles questioned whether the integration of non-Western vocal systems into the European aria form risks commodification. Bianconi defended the approach: “Tradition is not a vault. It is a conversation. When a Sámi joik enters the Neapolitan **canzone**, it does not replace—it converses. The aria becomes a site of dialogue, not conquest.” Risks, both artistic and institutional, are inherent. The volume’s

experimental nature limits mainstream commercial appeal; early sales indicate niche demand, though institutional subscriptions have exceeded projections by 40%. There is also the existential risk of performative diversity—where inclusion becomes a brand gesture rather than systemic change.
