Meanwhile, newly independent nations in Africa, Asia, and Latin America used the Council’s emphasis on inculturation—most powerfully in the document *\*Ad Gentes\**—to challenge missionary paternalism and assert cultural agency. The Council thus became a battleground not just of theology but of global power. Economically, Vatican II unfolded amid decolonization and the rise of development theology. The Church’s financial and administrative structures, long centralized in Rome and rooted in European patronage, faced scrutiny. documents rippled across multiple domains. Liturgically, *\*Sacrosanctum Concilium\** redefined the Mass through vernacular languages, lay participation, and a renewed focus on Scripture—transforming Catholic worship from a largely opaque ritual into a communal act of encounter. Yet these advances were tempered by persistent institutional resistance and the slow pace of theological reconciliation. The documents' global comparisons reveal both universality and fracture. While *\*Dignitatis Humanae\** aligned Catholic teaching with emerging human rights norms, its reception varied drastically: embraced in Western Europe, contested in Latin America under dictatorships, and embraced cautiously in Africa, where Catholicism often coexisted with indigenous spiritual systems. Similarly, *\*Gaudium et Spes\**, the Pastoral Constitution on the Church in the Modern World, articulated a vision of integral human development that

resonated with UN goals but faced skepticism from both secular and conservative Catholic quarters. The Council's aspiration for a "Church universal" clashed with local particularisms, exposing the fault lines between global ideology and regional identity. Underlying all this was an unprecedented media revolution. The Council marked the first truly global televised papal event. For the first time, billions witnessed the papal language shift, the liturgy in vernacular, the bishops debating in public forums. This media immersion transformed Catholicism from an insular institution into a visible, participatory global actor. Photojournalists captured moments—John XXIII's humble presence, the conciliar assembly in St. Peter's Basilica—becoming icons of renewal. The Church's image, once associated with dogmatic rigidity, was rebranded through live coverage: dialogic, inclusive, forward-looking. Yet this visibility also amplified dissent. Critics, armed with new media tools, dissected every gesture, every word, turning the Council into a live narrative of both hope and fracture. Expert analysis reveals that Vatican II's true strength lies not in its final decrees but in its ongoing process. The documents remain interpretive foundations, not final verdicts. The 2023 Synod on Synodality, for instance, echoes Vatican II's call for collegiality and participatory governance—proving the Council's living legacy.
