These were not abstract statistics, but human stories—names, ages, locations—recorded in a handwritten journal later digitized and encrypted. By 2005, the collection had grown into a loose manuscript titled *\*Trissel: A Field Guide to the Injection Economy\**. The name itself was an anomaly—a mismatch in spelling, yet deliberate. “Trissel” may derive from “transist,” a phonetic echo of “triad,” referencing the three core drugs observed—heroin, methamphetamine, and tricyclics—though users defy such categorization. Alternatively, it may be a phonetic hybrid of “triad” and “transmission,” capturing both the network and the spread. The title remained unclaimed, a statement in itself: no authority, no founder, only a collective

witness. The Handbook's early distribution was analog: photocopied pages passed through safe houses, copied onto USB drives smuggled across borders. It arrived in Latin America via Colombian medics treating HIV-positive street users; in Eastern Europe, in Russian hospitals where morphine addiction among veterans had gone unmonitored; in sub-Saharan Africa, in informal clinics serving migrants from conflict zones. Each copy was annotated with local context—new drug variants, local law enforcement tactics, cultural stigmas. Its authors were not ideologues, nor criminals, but pragmatists. One contributor, a former Romanian forensic pathologist, wrote: "We don't judge—the we record. Every injection site tells a story of neglect, but also resilience." Another, a Thai public health researcher, noted: "This isn't about drugs. It's about the spaces where the state doesn't reach—and the markets that fill that void."
