Initially a spiritual leader, Bhindranwale rapidly became the symbolic voice of a growing movement that fused religious authority with political assertion. His rhetoric, amplified by a network of militant associates, framed the struggle not as separatism but as a reclamation of Sikh sovereignty within India—a binary between “true” Sikh identity and perceived state encroachment. By 1982, his influence had grown to the extent that Punjab’s state government, led by Prime Minister Charan Singh, faced mounting pressure to negotiate a political settlement. Yet, the central government under Prime Minister Indira Gandhi viewed Bhindranwale and his growing following as an existential threat. The Congress-led regime, preoccupied with economic instability, rising separatist movements in Assam and Kashmir, and a fragile coalition balance, perceived any challenge to its authority—especially one cloaked in religious legitimacy—as intolerable. Intelligence assessments, later declassified in fragmented form, indicate that Gandhi feared a domino effect: if Punjab’s Sikh leadership could demand autonomy under religious pretext, other regions might follow. The operation—Operation Blue Star—was thus framed internally not as suppression, but as a preventive assertion of national unity. The planning and execution of Blue Star reflected both military precision and profound political miscalculation. On June 1, 1984, the Indian Army launched a multi-pronged assault on the Golden Temple complex in Amritsar, Sikhism’s holiest site.
